Call to Order

A paramedic with the Mcminnville fire department commented on how much better the level of service was with Trampas as Chief. Craig Saurs commented asking how can you judge the difference in the level of service in such a short time. Steve Featherstone commented that the investigation will show the facts and that he has very little confidence in the board and asked for the resignation of Jim, Jon, Clint, and Paul. Taylor Peters commented again on her frustrations that the volunteers that left came back into their original positions and announced that the district is failing to get out on calls. Brad Salter noted that we answer our district's call first then we help our neighbors if we have the manpower, at this time Rosanna interrupted Brad and Amber made a request for the Zoom meeting recordings, it was noted to place the request with the chief and it will be taken care of. Josie Smith noted that they did not come back to their original positions, and also noted that we turned down the mutual aid calls to protect our own district. Lastly Will Reber commented that we all need to wait for the investigation to be complete and have the facts to make a decision.

Financial Report/ Past minutes

Past meeting minutes were presented and discussion was had starting with the 8/7 Meeting minutes, Jon was very unhappy with the minutes as presented and made a motion to strike the minutes from the record motion as made seconded by Clint, Motion failed with Jon and Clint in favor and Jim, Paul, and Josh in opposition. Lastly a motion was entertained by Paul and seconded by Josh to approve the 8/1 meeting minutes motion passed unanimously with Clint and Jon abstaining.

A motion was also entertained by Clint and seconded by Jon to approve the monthly financials motion passed with Josh Brown abstaining.
